The seat of the arbitration shall be Vietnam and Arbitration shall be conducted in Vietnam in the English language in accordance with the VIAC Rules. The tribunal shall consist of one (1) arbitrator to be

appointed by mutual agreement between the Parties. Either Party may propose to the other the name or names of one (1) or more persons to serve as the arbitrator. If no agreement is reached within thirty (30) days after receipt by one (1) Party of such a proposal from the other, the arbitrator shall be appointed by VIAC.

25. Languages

This agreement is drafted in the English language. If this agreement is translated into any other language, the English language version shall prevail.
